ORDER

On May 22, 2024, the Arkansas Public Service Commission (Commission) issued Order No. 4, establishing a procedural schedule to investigate the Application filed by Liberty Utilities (Arkansas Water) Corp.'s (LUAW or Company) for approval of a general change or modification in rates, charges, and tariffs. Order No. 4 scheduled a public comment hearing for Thursday, December 5, 2024, but stated that the location and time of the public comment hearing was to be determined in a subsequent filing by LUAW (Doc. #59).

On November 1, 2024, LUAW filed a *Motion to Amend Procedural Schedule to Set Time and Location for Public Comment Hearing* (Motion) requesting to amend the procedural schedule to include the following information for the public comment hearing:

Location: White Hall City Court

Date and Time: Thursday, December 5, 2024, at 6:00 p.m.

The Motion states that LUAW discussed the proposed time and location with the Commission General Staff (Staff) and the Office of Arkansas Attorney General Tim Griffin (AG), and that Staff has stated that it does not object to the proposed time and location, while the AG has not responded to the Company's requests. *Id.* \P 2.

The Commission finds that the proposed location and time for the public comment hearing is reasonable and in the public interest and therefore grants LUAW's Motion.

The Public Comment Hearing on the Company's Application is scheduled to begin at **6:00 p.m. on Thursday, December 5, 2024**, at White Hall City Court, 101 Parkway Dr., White Hall, AR 71602.

Liberty is directed to prominently display the date, location, and purpose¹ of this hearing, as well as the previously scheduled evidentiary hearing, on its website.
