ORDER

On November 3, 2022, the Arkansas Public Service Commission (Commission) issued Order No. 2, establishing a procedural schedule to investigate the Application filed by Liberty Utilities (Pine Bluff Water) Inc. (Liberty) for approval of a general change or modification in rates, charges, and tariffs. Order No. 2 scheduled a public comment hearing for Thursday, July 6, 2023, but stated that the location and time of the public comment hearing would be set by a future order.

On November 16, 2022, the General Staff (Staff) of the Commission filed a *Motion* to Add Public Comment Hearing Information to the Procedural Schedule (Motion) requesting to amend the procedural schedule to include the following information for the public comment hearing:

Motion ¶¶ 5-7 (Doc. #53). The Motion also states that Staff worked with Liberty on the proposed location and time and that the Office of Attorney General Leslie Rutledge does not have an objection to the proposed time. Id.

The Commission finds that the proposed location and time for the public comment hearing is reasonable.

The Public Comment Hearing on Liberty's Application is scheduled to begin at **6:00 p.m. on Thursday, July 6, 2023,** at the Pine Bluff Convention Center, #1 Convention Center Plaza, Pine Bluff, Arkansas.

Liberty is directed to prominently display the date, location, and purpose¹ of this hearing, as well as the previously-scheduled evidentiary hearing, on its website.
